## STATEMENT OF NATURE, REASONS AND BASIS

The purpose of this filing is to submit to the Commission an updated list of non-conforming agreements to reflect two new Rate Schedule FTS-3 service agreements with City of Lakeland that are proposed to be effective December 1, 2024, the anticipated effective date of the non-conforming agreements coinciding with the in-service date of the FGT Lakeland Project in Docket No. CP23-491-000.

FGT is making a concurrent filing to add the two new non-conforming service agreements as tariff records in its Original Volume No. 1-A Tariff.

#### IMPLEMENTATION AND WAIVER REQUEST

Pursuant to Section 154.7(a)(9) of the Commission's Regulations, FGT requests that the proposed tariff record submitted herewith be accepted effective December 1, 2024, the commencement date of the two new non-conforming service agreements. FGT respectfully requests that the Commission grant waiver of Section 154.207 of the Commission's Regulations and any other waivers of its Regulations that it deems necessary to allow the proposed tariff record in this filing to become effective on December 1, 2024.
