### STATEMENT OF NATURE, REASONS AND BASIS

The purpose of this filing is to comply with Order No. 587-AA, Final Rule issued on November 22, 2024 in Docket No. RM96-1-043, 189 FERC ¶ 61,135 (2024). The Wholesale Gas Quadrant ("WGQ") of the North American Energy Standards Board ("NAESB") promulgated new and revised standards which were adopted by the Commission and incorporated by reference in the Commission's Regulations. The revised tariff section included herewith reflects the NAESB standards in Version 4.0. The Version 4.0 business practice standards replace all of the earlier versions of the business practice standards that were previously incorporated by reference in the Commission's Regulations.

FGT proposes to modify GT&C Section 25 "Business Practices Standards" to reflect all of the NAESB Version 4.0 gas standards and datasets incorporated by reference in accordance with the recommended format set forth in the Final Rule.
