Dear Ms. Reese:

On April 25, 2024, the Federal Energy Regulatory Commission (“Commission”) issued an Order Issuing Certificate (“Certificate Order”)<sup>1</sup> in Docket No. CP23-492-000, granting Florida Gas Transmission Company, LLC (“FGT”) authorization under Section 7(c) of the Natural Gas Act and Part 157 of the Commission’s Regulations to construct and operate FGT’s South Louisiana Project (“Project”), as more fully described in the application and as conditioned in the body and ordering paragraphs of such Certificate Order.

On May 3, 2024, FGT filed tariff records in compliance with Ordering Paragraph (B)(4) of the Certificate Order, in order to execute a firm service agreement for volumes and service terms equivalent to those in a precedent agreement before construction could commence on the Project (“Compliance Filing”).<sup>2</sup> Subsequently, on June 3, 2024, FGT filed a revised tariff record related to Rate Schedule FTS-WD-3, Firm Transportation Service, to modify directional language that was inadvertently included related to Alternate Receipt and Delivery Points (“Revised Rate Schedule Filing”).<sup>3</sup>

While the Commission has been previously notified that certain facilities associated with the Project have been placed into service, all remaining Project facilities will be in-service by April 1, 2025. Therefore, as directed by the Commission’s letter orders regarding both the Compliance Filing and the Revised Rate Schedule Filing, FGT hereby submits this notification for the effective date of the tariff records, listed herewith on Appendix A, as April 1, 2025. FGT is purposely omitting tariff record, GT&C Section 1., Definitions, version 11.0.0 from Appendix A as this tariff record has been superseded by the currently effective version 12.0.0 in FGT’s tariff.
